- DO NOT use abrasive pads, cleaners or industrial strength glass cleaners.
- Use a soft cloth with a mild soap and water solution. That's it!
- Allow film to cure for 3 to 5 days before lowering windows.
- REMEMBER: Your new film takes 2 to 3 weeks to fully cure. You may see some haze or condensation during this period.

The Manufacturer warrants the LLumar® Window Film Products ("Products") specified below against cracking, peeling, or demetallizing when properly installed in a vehicle in accordance with the Manufacturer's recommended installation procedure.

### LIFETIME LIMITED WARRANTY COVERAGE ("Warranty") for Products ATC CH, ATR CH, CTX CH, IRX CH, AU UV and AIR BL

- If any Products specified above fails to conform to the Warranty during the warranty coverage period, the purchaser may obtain replacement and installation of the Product free of charge at any LLumar Dealer anywhere in the United States or Canada, per the Warranty coverage stated herein.
- Products covered under the Warranty are also warranted against unusual change of color (e.g. – purple).
- The Warranty does not cover fading or anything else other than specified above.
- The Warranty is limited to coverage for vehicles such as sedans, mini-vans, SUVs, trucks and tractor trailers. This Warranty does not cover motor coaches, tractors, boats, RVs and sunroofs.
- This Warranty does not cover or apply to and the Products should not be applied to or on acrylic or plastic windows and interior glass surfaces with any type of coating applied.
- The Warranty also does not cover improper installation. The LLumar Dealer is responsible for correcting any improper installation.
